- 1. A request has been received from M/s Chakr Innovation Pvt. Ltd., on the above subject. The matter has been examined and the following observations have been made:
 - a). M/s Chakr Innovation Pvt. Ltd., is a manufacturer of Retrofit Emission Control Device (RECD) Equipments having manufacturing facilities at: Survey No. 236, Hissa No. 7 & Survey No. 237, Hinjewadi, Taluka Mulshi, Pune, Maharashtra, 411057.
 - b). The unit has given declaration that they have not produced any device during COP year 2023-24 and requested for **CoP exemption** for 2023-24 for its identified RECD models.
- 2. As per sub clause 5.7.1, 5.7.2 & 5.7.3 of clause 5.7 "Exemption of CoP" of System and Procedure of the RECD:
 - 5.7.1 In case of no production or import, the manufacturer shall submit a declaration to technical agency for No production or import of a particular family model for every CoP-year.
 - 5.7.2 CoP test shall be conducted by technical agency for the next CoP-year, upon receipt of declaration by the manaufacturer that there was no production or import during current CoP-year.
 - 5.7.3 Declaration in this regard should be submitted before 31 March of the current CoP-year.

- 3. In view of above CoP Exemption request accepted with a condition that once production resume, manufacturer shall inform to technical & Nodel agencies and the CoP would be carried by as per para 5.0 of the System & Procedure (PCLS/12/2021-22).
- 4. Next CoP test shall be carried out before 01st July 2025 (i.e. once in a year) or after production of every 500 units for the above family, whichever is earlier.
- 5. This certificate supercedes the earlier certificate No. CCTG 0204 dt. 25.09.2024.
