10. No handling charge will be levied where such test property are component delivered for testing. Upon the expiry of six weeks of intimation to the customer by ICAT that the component has been tested. ICAT shall have the right to destroy the component.

11. Handling charges shall be payable by the Customer at time of collection of property from ICAT.

12. If the test property is not collected within 12 months from date of intimation by ICAT to the customer that the test property has been tested, the right to auction the test property in order to recover the proceeds thereof the charges in respect of handling the auction of the property, as well as any other charges payable. The balance if any from the proceeds of such auction may be collected by the customer within 30 days of the date of auction failing which said balance amount will be forfeited in favor of ICAT.

13. ICAT shall have right to set-off any advance or payment outstanding in the name of Customer against the payment of this PI.

14. The remedies provided here in above shall be communicative & in addition to any other or further remedies available to ICAT in law or equality.

15. Customer and ICAT are independent contracting parties and nothing herein shall make either party the agent or legal representative of any purpose whatsoever.

16. The customer shall not, without first obtaining the written consent of ICAT, in any manner advertise or publish the fact that test property is tested at ICAT.

17. Contents of the PI are confidential between the parties and nothing herein shall make either party the agent or legal representative employees (on a need to know basis), legal or professional advisors or to extend mandated by any law or authority of competent jurisdiction.

18. Except to extend the parties have entered into written contracts previously which are not modified by this PI. This PI constitutes the entire agreement between the parties in respect of the subject matter hereof.

19. The customer warrants that the test property specified herein will not infringe any Indian or foreign patents, copyrights, trademarks or other intellectual property rights and agrees to indemnify ICAT from costs resulting from any such infringement.

20. In no event shall ICAT be liable for any direct, indirect, consequential, economic or financial losses or incidental damages arising out of this work under PI.

21. Notwithstanding the foregoing, ICAT may cancel this PI without liability in the event of any causes beyond its control, such as, but not limited to, flood, draught, fire, war, riot, act of terrorism, acts of GOD or of any Government Authority.
